During this period, all candidates must file declaration of candidacy and nomination papers. No person may file nomination papers for more than one office at the same election. The declaration of candidacy shall be executed in the elections official's office. All candidates must pay the nonrefundable filing fees or present in lieu signatures at the time they receive their nomination papers. The number of valid in lieu signatures obtained by the candidate may be subtracted from the number required for his or her nomination papers. A candidate shall not be required to execute a nomination paper if the number of in lieu signatures that meets the nomination requirement on the in lieu petitions equals or exceeds the minimum number required.

If only one person has declared candidacy for a voter-nominated office at the Primary Election and that candidate dies after **March 9 (E-88)** but prior to **March 14 (E-83)**, any person qualified under E.C. 8001 may circulate and deliver nomination documents for the office to the county elections official not later than **5:00 p.m.** on **March 23, 2018.**
