SUBJECT: Updated Fictitious Business Name (FBN) portal and form

The Los Angeles County Registrar-Recorder/County Clerk will be releasing a new online portal in a phased approach for the filing of all Fictitious Business Name (FBN) Statements.

Phase One -

- Goes live on Monday, July 12, 2021 with a replacement of the current web screens and a new FBN form including the following updates:
 - LA County seal watermark has been added
 - Removal of the box to select the type of FBN filing
 - Removal of the page 2 legal references
- During this phase we will only accept mail in statements.
- After the County re-opens to the public, we will begin acceptance of these statements through an appointment system. All customers can then choose in person or courier appointments or mail in option.

Phase Two of this new module will be released in the Fall of 2021 and will include online identification and credit card payments to allow for customers to have a completely electronic transaction where the filed FBN will be returned to the customer via email.
